1 Name of instrument

This instrument is the *Monitoring of Places of Detention (Optional Protocol to the Convention Against Torture) Delegation 2026 (No 1)*

2 Commencement

This instrument commences the day it is signed.

3 Delegation

Acting under s 8I of the *Monitoring of Places of Detention (Optional Protocol to the Convention Against Torture) 2018* (the Act) I delegate to each member of my staff the functions conferred on me by the provisions identified in column 2 of schedule 1 to the person from time to time occupying the position identified in column 3 of schedule 1.

Note The *Legislation Act 2001* defines “occupy”, in relation to a position, as including: to hold the position, act in the position or exercise functions of the position.
